Rules & Regulations

1. All championship dogs must be purebred and registered on NZKC No. 1 or No. 3 register.
2. Trials to be run under the rules and regulations of the NZGTA. Rules and Regulations will be available at the Headquarters.
3. All competitors must be a current financial member of an affiliated club.
4. No late entries will be accepted.
5. All competitors & dogs compete at their own risk.
6. All dogs must be on a lead unless competing or in a designated exercise area.
7. Penalty for breach of Reg. Gen.7(c) is \$10.
8. Engraving to be the responsibility and cost of the winner.
9. The committee reserves the right to alter judges and grounds if required.
10. Full pedigree name and registration number must be supplied at time of entry.
11. **A current dosing certificate will be required to be sighted by the Secretary at the hall before any dog (including non-competing dogs) enters the trial grounds. The certificate must confirm that the dog has been dosed not less than 48 hours prior to the trial date and not longer than 35 days prior to trial date. Copies of current certificates may be FORWARDED/EMAILED to the Club Secretary prior to the event.**

NZ CHAMPIONSHIP SPECIAL TROPHIES:

Thorburn Cup (donated by S A Thorburn, 1967): Highest aggregate score in All Breeds & Breed event at NZ Championships.

James Reid Memorial Cup (donated by J & G Reid, 1963): Spaniel gaining most point in All Breeds at NZ Championships.

Shadow Cup (donated by K E Helson, 1983): Retriever gaining highest aggregate score in NZ and Island (held in conjunction with NZ Championships) Retriever Championship.

Jim Reid Memorial Trophy (donated by Jocelyn Reid, 1997): Spaniel gaining highest aggregate score in NZ and Island (held in conjunction with NZ Championships) Spaniel Championship.

Tom Catherall Memorial Trophy (donated by the Catherall Family, 1999): Non-champion spaniel gaining the highest aggregate points in the NZ All Breeds and NZ Spaniel Championship Field Trials.

Bill Streeter Memorial Trophy (donated by Mrs M Streeter, 1992): To be presented annually to the non-champion dog gaining the highest aggregate points in the NZ All Breeds and NZ Retriever Championship Field Trials.

Champion of Champions (donated by W K Donaldson and Family, 1981): Competitors at NZ Championship being FTCh, GFTCh, GFCh or FCh gaining the highest aggregate score in All Breeds and Breed events. Entries to be made to the field trial secretary by 7.30am on the first day of the trial. Entry Fee: \$1 per dog.

Cornhill Shield (donated by J Penno, 1949): For competition between clubs in NZ All Breeds Championship. Clubs may nominate three dogs and one reserve (one team only). All owners to be financial members of nominating club. All entries to be in writing from Club Secretary and accompanied by entry fee of \$1 per team member. Entries close with the host secretary by 7.30am on the first day of the trial.

Inter-Island Trophy (donated by W A Streeter, 1988): Team of 4 dogs and 1 reserve from each island. Dogs can run in any class – All Breeds, Retriever, Pointer Setter, Spaniel. Clubs or persons may nominate any dog or dogs that have performed to their satisfaction. This nomination must be received by the Association Secretary 1 month before the NZ Champs. North Island Executive will select North Island Team; South Island Executive will select South Island Team.

Bruce Brady Memorial Trophy (donated by the Brady Family, 2001): Presented to the Retriever gaining most points calculated on all Retriever Championships throughout the year.

John Gaskin Memorial Trophy (donated by R Gaskin, 2007): Calculated over all Natural Game Championship Trials throughout the year.

Gordon Clarke Memorial Trophy (donated by the Clarke Family, 2009): Presented to the All Breeds dog gaining the most points calculated on all All Breeds Range, Find and Flush Championship Trials throughout the year.

Coveybrooke Memorial Trophy (donated by Graeme Palmer and Sonya Tamblyn 2016): Calculated on all Retriever Walk-Up and Natural Game Championship Trials throughout the year.

NZ Gundog of the Year Trophy (donated anonymously, 1982): Presented to the dog that gains the most challenge points (National trials not included) during the year – AGM to AGM.

LAND No. 1:

Heel retrieve two thrown birds and one blind bird. Shot to be fired by handler in the direction of the blind bird first then shots to be fired by handler over dog while birds are in the air. Birds to be retrieved in any order.

LAND No. 2:

Heel retrieve three thrown birds. Shot to be fired by handler over dog while birds are in the air.
