Then retrieve one planted blind, shot to be fired by handler in the direction of game.

LAND/ WATER: JUDGE: Dave Murray

Heel retrieve three game. Shot to be fired by Handler on release of two thrown birds.

Then retrieve one planted blind, shot to be fired by handler in the direction of game.

Dogs will be braced according to the draw and be expected to run, hunt, find and Point / Set Pigeons staunchly, and to back. They must be steady to Flush & Shot. Second round or placed dogs will be tested on a concealed dead bird retrieve which will be incorporated into their work.
