# CHAMPIONSHIP TRIALS

## North Island All Breeds Heel Retrieve Championship Saturday 21<sup>st</sup> (Both courses)

Entry Fee \$20 (NZGTA levy incl)

**JUDGES:** Land – Sandra Williams Water – Tony Clay

**LAND:** Heel retrieve three thrown birds on land. Shot to be fired by the handler over dog on bird release.

**WATER:** Heel retrieve two thrown birds on or across water. Shot to be fired by the handler over dog on bird release.

**TWO CHALLENGE POINTS & NORTH ISLAND ALL BREEDS CUP to the winner of the aggregate. Ribbon and certificate for the first, second and third placed aggregates.**

## North Island Retriever Championship Saturday 21<sup>st</sup> (Section 1) – Sunday 22<sup>nd</sup> (Sections 2 & 3)

Entry Fee \$20 (NZGTA levy incl)

**JUDGES:** S1 – Te Anderson S2 – Maree Dickey S3 – Tahi Spinks

**Section 1:** Heel retrieve three thrown birds on land. Shot to be fired by the handler over dog on bird release.

**Section 2:** Heel retrieve three birds on or across water. Shot to be fired by the handler over dog for each bird. Two thrown birds & one blind bird.

**Section 3:** Heel retrieve three birds on land & on or across water. Shot to be fired by the handler over dog for each bird. Two thrown birds & one blind bird.

**TWO CHALLENGE POINTS & NORTH ISLAND RETRIEVER CUP to the winner of the aggregate. Ribbon and certificate for the first, second and third placed aggregates.**

## North Island Spaniel Championship Saturday 21<sup>st</sup> (Land) – Sunday 22<sup>nd</sup> (Water)

Entry Fee \$20 (NZGTA levy incl)

**JUDGES:** Land – Dave Richardson Water – Peter Spinks

**LAND:** Range, find & flush one homer. Range find & retrieve one dead bird concealed in cover (shot fired on the workup to finding the dead bird). Range, find & flush one homer.

**WATER:** Heel retrieve two thrown birds across or on water. Shot to be fired by the handler over dog on bird release.

**TWO CHALLENGE POINTS & NORTH ISLAND SPANIEL CUP to the winner of the aggregate. Ribbon and certificate for the first, second and third placed aggregates.**



## North Island Pointer & Setter Championship – Saturday 21<sup>st</sup>

Entry Fee \$20 (NZGTA levy incl)

**JUDGES:** Tony Conner & Rob Meredith

Dogs will be braced according to a public draw, held just prior to the trial. Dogs are expected to run, hunt, find and point/set pigeons staunchly, and to back. They must be steady to flush & shot. Second round or placed dogs will be tested on a concealed dead bird retrieve.

**TWO CHALLENGE POINTS AND NORTH ISLAND POINTER AND SETTER CUP to the winner of the aggregate. Ribbon and certificate for the first, second and third placed aggregates.**

## MINOR TRIALS

### North Island Puppy – Saturday 21st

**JUDGES:** To be advised

Entry Fee \$10

**LAND:** Heel retrieve one thrown bird or dummy on land. Shot to be fired by the handler over dog on game release.

**WATER:** Heel retrieve one thrown bird or dummy across or on water. Shot to be fired by the handler over dog on game release.

**NORTH ISLAND PUPPY SHIELD to the winner of the aggregate. Ribbon and certificate for the 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup>.**

### North Island Novice – Saturday 21st

**JUDGES:** To be advised

Entry Fee \$15

**LAND:** Heel retrieve two thrown birds consecutively on land. Shot to be fired by the handler over dog on release of each bird.

**WATER:** Heel retrieve two thrown birds consecutively across or on water. Shot to be fired by the handler over dog on release of each bird.

**NORTH ISLAND NOVICE SHIELD to the winner of the aggregate. Ribbon and certificate for the 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup>.**

### North Island Limit – Saturday 21st

**JUDGES:** To be advised

Entry Fee \$15

**LAND:** Heel retrieve two thrown birds on land. Shot to be fired by the handler over dog on release of each bird.

**WATER:** Heel retrieve two thrown birds across or on water. Shot to be fired by the handler over dog on release of each bird.

**NORTH ISLAND LIMIT SHIELD to the winner of the aggregate. Ribbon and certificate for the 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup>.**



## **CONDITIONS OF ENTRY**

1. All championship dogs must be purebred & registered on the Dogs NZ Purebred Dog Registry (Part I or Part III).
2. Registration numbers must be supplied with championship entries.
3. This schedule has been approved by, and the trials will be run under the NZGTA Rules & Regulations. These rules will be available on the day.
4. Game in good condition will be used for each dog in each section of the Championship events.
5. All competitors must be a current financial member of an NZGTA affiliated club.
6. A firearms briefing will be given to competitors before each trial. If you do not hold a NZ firearms licence, you must be supervised by a licenced person when handling a gun. Gun safety to always be observed & applied.
7. All competitors / visitors and dogs compete at their own risk.
8. The committee reserves the right to make any alterations to this schedule to meet any unforeseen circumstances.
9. There will be a penalty of \$10 for any dog that is in breach of Regulation Gen.7 (c).
